SC reserves verdict on whether to refer to larger bench the decision in "Nabam Rebia vs Deputy Speaker"

; Supreme Court's fivejudge Constitution bench on Thursday reserves its verdict on whether to refer the cases related to the Maharashtra political crisis to a larger seven-judge or nine-judge bench for reconsideration of a 2016 Nabam Rebia judgment on the powers of Assembly Speakers to deal with disqualification pleas.

five-judge constitution bench of the Supreme Court, headed by the Chief Justice of India (CJI) Dr Dhananjaya Yeshwant Chadrachud, reserved the judgment after hearing detailed arguments and submissions from Eknath Shinde, Uddhav Thackeray, State Assembly Speaker side and others.

The Apex Court today reserved the judgment on if 5-judge Nebam Rebia judgment required to be reviewed by a larger 7 or 9 judge bench. The Apex Court's other

four judges, besides CJI, who were part of the forum were: Justices MR Shah. **Newly appointed Maha Governor Ramesh**

Krishna Murari, Hima Kohli and PS Narasimha.

Uddhav Thackeray faction of Shiv Sena sought that five-judge Nabam Rebia case be referred to seven judge bench for

reconsideration. In 2016 Nabam Rebia case, the five-indee Constitution bench of the Supreme Court, had held that Speaker cannot initiate disqualification proceedings when resolution seeking his removal is pending. Senior advocate Kapil

Sibal appearing for Uddhav Thackeray camp submitted that there is an imperative need to reconsider the law laid down in Nabam Rebia case."It's time for us to relook at Nabam Rebia and the 10th Schedule because it has created havoc," Sibal has said.Sibal sought a direction for reference to a per bench for ensideration the 2016 bench judgement by a sevenjudge bench.Senior
